Moved and Seconded: Minutes of the February 2024 WIARC meeting

The February 2024 meeting of WIARC was called to order at 7 pm by President W9US with the following members and guests present:

Introductions were accomplished.....

Minutes of the January meeting were approved WB9EWM WA9GBC.

In absence of treasurer, no report was given.

W9WE: Treasurer reports that K9VXD and W9DP need to sign some paperwork to get KD9PPJ on the bank card.

Repeater Board: recommend that a repeater be purchased from Yaesu so all repeaters (including 147.195) would be same equipment. Also recommend we move equipment from the Channel 10 tower to Adams County tower "sooner than later".

Considering sale of the D-Star equipment and possible disposal or repair of other equipment. WB9EWM (WA9GBC) moved to purchase another DR2X and consider an amplifier. Carried.

Repeater Board planning to meet at the Channel 7 site and consolidate items and "clean up". Also considering renting a storage unit for a period of time (preferably not more than 6 months).

Proposing listing the SCOM controllers for sale.

WB9EWM moved sending DR1X in for repair at cost not to exceed \$300. W9WE second carried.

Discussion regarding storage. KD0DKE has a possible site; otherwise the Repeater Board will investigate storage. WB9EWM moved to check Scott's place, (N9BZ), carried

Contest Committee: ILQP results are completed, mostly posted to the web. W9DP reports plaques are finished and ready to be mailed. State QSO parties have begun again with MN, VT

Club Station: W9DP put a new mic cord that needed replacement. WA9GBC: OCFD needs to be put up again. Might call in a favor from electric company or someone else with a bucket truck. WB9EWM will check with Operations Mgr at Adams Electric.

Old Business: sealed bid auction: newer antenna analyzer will be kept by club to loan out to club members (WB9EWM, NR9Q) carried.

Hamfest report from W6JFL: recently e-mailed lots of IL and MO clubs and vendors with flyer and invite letter for spring hamfest (May 4); lots of tables left.... He and N9MAF have investigated the site in Palmyra. Have some wristbands and planning for 200 attendees. Discussion of colors of wristbands. ARLB003 Senate Bill S.3690 Introduced to Eliminate Private Land Use Restrictions on Amateur Radio

On January 30, 2024, US Senators Roger Wicker (MS) and Richard Blumenthal (CT) introduced S.3690, the Senate companion bill to H.R.4006, introduced last June. Both bills reflect the Congressional campaign efforts by the ARRL to eliminate homeowner association land use restrictions that prohibit, restrict, or impair the ability of an Amateur Radio Operator to install and operate amateur station antennas on residential properties they own.

Amateur Radio Operators repeatedly are relied upon to provide essential communications when disaster strikes, but their ability to do so is being impaired by the exponential growth of residential private land use restrictions that hinder their ability to establish stations in their homes with which to train and provide emergency communications when called upon.

In announcing the introduction of S.3690, Senator Wicker said: "Because communication during natural disasters is often hindered, we should be making every attempt to give folks more options.

Reliable access can make the difference between life and death in an emergency. Our legislation removes roadblocks for amateur radio operators looking to help their friends, families, and neighbors."

In a similar announcement, Senator Blumenthal stated: "Our measure will help clarify the rules so ham radio enthusiasts can successfully continue their communications. In the face of emergency or crisis, they help provide vital, life-saving information that allow listeners to properly and safely respond, but prohibitive home association rules and confusing approval processes for installing antennas have been an unnecessary impediment. The Amateur Radio Emergency Preparedness Act resolves these bottlenecks and ensures that radio operators can function successfully."

ARRL President Rick Roderick, K5UR, and Director John Robert Stratton, N5AUS, Chair of the ARRL's Government Affairs Committee, both extended on behalf of ARRL, its Members, and the Amateur Radio community their thanks and appreciation for the leadership of Senator Wicker and Senator Blumenthal in their continuing efforts to support and protect the rights of all Amateur Radio Operators.

Georgia State Parks on the Air 2024

The second annual <u>Georgia State Parks on the Air</u> will be held April 6 - 7, 2024. ARRL member and event coordinator Claude Ray, AC4SH, said that the first event was a success and that participants insisted on having another one.

"For both activators and hunters, the event went far beyond our expectations. Of the 50 listed parks, 48 were activated, with 109 activators making nearly 20,000 contacts with over 4,000 hunters," said Ray. He added that the 2024 event promises to be even better, with the addition of two new Georgia parks and, based on feedback from participants, the rules have been tweaked to add new opportunities receiving awards.



There are now separate classes for rovers and single-park activators, as well as a new category for QRP activators. There are also new bonuses available, not only for past winners but also for first-time activators and those who contact the two newly added locations. A new hike-in bonus has been added for operators who carry their gear more than a mile into the park and activate from there. Ray said the basic purpose of the event remains the same. "The objective is to encourage ham radio operators to visit Georgia state parks and experience the fun of Parks on the Air activations. This is a fun contest only. The rules are minimal, the scoring is simple, and the main award is simply the fun of getting on the air."

The contest period begins at 8:00 AM EDT on April 6, and ends at 7:59 PM EDT on April 7. Operating hours are subject to park rules and times. Every station participating in the event and registering will, upon request, receive a certificate of participation. The top finishers in each category will also receive an award certificate.
