Moved and Seconded: Minutes of the September 2024 WIARC Meeting

The September 4th, 2024, meeting of WIARC was called to order at 7:00 pm by Dave KB9FIN, Vice President, with the following members and guests present:

KB9FIN, KD9PPJ, K9AJC, W9WE, WA9GBC, K9VXD, KD9VUW, KB9GIY, KE7RR, KA0SNL, KD0HDL, AA9GL, AB9DU, K0DKE, WM4D, WB9EWM with N9JF and W9US on Zoom.

Introductions were made...

John WB9EWM, motioned to accept the August meeting minutes, seconded by Arnold K9VXD, motion accepted by membership present.

Treasurers Report: Jack KD9PPJ reported that the club checking account had \$4499.00, and the 2 CDs were at \$5000.00 each. He stated that he had a receipt from WB9EWM in the amount of \$59.25 for the RT Systems programming software for the new Yeasu dual band radio purchased last month. KD9PPJ made the motion to reimburse WB9EWM for \$59.25 and was seconded by Dave W9WE and accepted by membership present.

Membership Committee: Jim N9JF did not have any new information since the last meeting.

Repeater Board: John WB9EWM everything was working well, no one has said anything. WB9EWM stated that he put out a different microphone on the 940 repeater in case he needed to key up the repeater from the repeater. WB9EWM had not spoken with the engineer with KHQA about the electricians putting in the grounding straps, he's been out of town and waiting for him to get back.

Club Station: All the equipment back in place and hooked up. Computers not hooked up and WB9EWM is recommending that we purchase new Club computers. WB9EWM also spoke about a new dual band Diamond X50 antenna with prices from several places with and without shipping. WB9EWM also brought up the necessity to put brackets/stand offs on the tower to move the dual band antenna away from the tower for better performance. A motion was made by Ron AA9GL for the purchase of the Diamond antenna with a purchase limit of \$120.00, motion was seconded by Shawn KD9VUW and motion passed unanimously by members present.

Old Business: Andy KA0SNL / Webmaster for the WIARC webpage, stated that the online payment system is pretty much set up on the website, but it is still in test mode and, he has added the application for membership to the page. KA0SNL said that he has placed detailed instructions on the application page for the perspective member to follow and understand per the By-Laws of the club pertaining to membership. Dave KB9FIN asked where the membership application was going to and KA0SNL stated that it can be set up to be sent to whomever, right now it is being sent to his email and can be changed. KA0SNL spoke about the different levels of membership available through the website and that by the end of the month everything should be completed and then will be live on the WIARC website. Payment processing should take about 2 business days and "STRIPE" is a third-party payment processor in which membership dues payments will be going through. KA0SNL assured everyone that nothing is stored and kept on the webpage, and that Stripe's security seems to be very strong with their payment processing.

Dave KB9FIN spoke about the Club website needing updating, Officers, repeaters information and other content information on the sight needs updated. KB9FIN also

questioned whether the payment processing system needs to have a separate account for the membership dues to go into from STRIPE instead of the main checking account that has all the club money in it in case of a cyberattack KB9FIN was concerned about having thousands of dollars in an account attached to a payment system. KA0SNL stated that we do not take payments on the actual website, that it is all done through the 3rd party payment processor, STRIPE, and all there is a link to the payment processor and there is not liability on the on the payment side because the club is not getting any of the payment information made to STRIPE for the membership dues. KA0SNL stated that no personal information or card information is stored on the website, that is all done through STRIPE. Ed W9US stated that KB9FIN had made a significant point and commented about having the checking account with all the club money attached to the Stripe account payment system in case of a breach. Suggested to make new account and move the money in the account attached to the STRIPE system to the new account, eliminating any extra work involved with attaching a new account to the STRIPE system.

KD9PPJ commented about the amount of money in the account and only leaving a thousand dollars in the account and moving the rest into CD's account. That the money in checking isn't making any money right now and CDs are making around 5 percent. Discussion was made about reviewing money allocations after the CD comes due in October. Ed W9US spoke about the station committee looking at possibly getting new radios for the club station that are easier to connect to the internet. John WB9EWM suggested making a list of wants and needs and bringing it to the membership at next month's meeting. Dave W9WE suggested spending the money, getting things fixed or updated. The Icom 746 Radio was brought up about being replaced with other radios that can connect to computers without an external sound card. Discussion was made and will be brought up in the October meeting after further discussion.

New Business: John WB9EWM sent out a club IO email about the sale of 2 club radios. I apologize that it was overlooked and not in last month's minutes.

Here is what is for sale... WIARC has 2 radios from the club radio station for sale.

- 1 Kenwood TM-271 VHF mobile, 60 watts, with mic, power cord and mounting bracket
- 1 Icom ID-880H, VHF/UHF, D-Star capable, 50 watts, wide band receive capability. Power cord, microphone, mounting bracket

Correspondence was received from the Boy Scout Council about the WIARC and members setting up and manning an Amateur Radio club display with working radios where the scouts can participate and learn more about the Amateur Radio hobby. TANZANIA, 5H. Vlad, OK2WX is QRV as 5H1WX from Mafia Island, IOTA AF-054, until October 6. Activity is on 80 to 10 meters using CW, SSB, and FT8. QSL via I8KHC.

BOTSWANA, A2. Pista, HA5AO will be QRV as A25AO from Chobe National Park from September 24 to October 4. QSL to home call.

SPAIN, EA. Special event station EG2AMCUP is QRV until October 29 during the 37th America's Cup being held in Barcelona. QSL via EA3MM.

MARQUESAS ISLANDS, FO. Paula, NX1P is QRV as FO/NX1P until October 1. Activity is on the HF bands. QSL to home call.

HAITI, HH. Special call sign 4V1SAVANNAH is QRV until October 20 to commemorate the 245th anniversary of the Battle of Savannah, an encounter of the American War of Independence. QSL via N2OO.

GREECE, SV. Dirk, ON5CT is QRV as SV8/ON5CT from Samos Island, IOTA EU-049, until October 6. Activity is on 80 to 6 meters using SSB, RTTY, and FT8. This includes being an entry in the upcoming CQ World Wide DX RTTY contest. QSL via LoTW.

ST, KITTS AND NEVIS, V4. John, W5JON is QRV as V47JA from St. Kitts, IOTA NA-104, until October 1. Activity is on 160 to 6 meters using SSB and FT8. QSL direct to home call.

NAMIBIA, V5. Gunter, DK2WH is QRV as V51WH from Omaruru until November 12. Activity is on 160 to 10 meters, including 60 meters, using SSB, FT8, and possibly CW. He will be active as V55Y in various contests. QSL to home call.

TRISTAN DA CUNHA AND GOUGH ISLAND, ZD9. Lance, W7GJ is QRV as ZD9GJ from Tristan da Cunha, IOTA AF-029, until October 1. Activity is primarily on 6 meters EME using Q65-60A in the Q65 Pileup mode. This may include some 6 meter TEP with SSB or FT8 as well. QSL direct to home call.

Any logging program is ok to use, but the log file you submit <u>must be in Cabrillo format.</u> The easiest thing is to use the Excel form on the website. It fits our needs perfectly!

Exploring the Northwest the Park Way with N9JF, KB9CES and WY0L

We enjoy traveling with my eldest brother, Dave, WY0L and his YL, Linda. We never run out of things to discuss; we all notice birds and admire scenery. Dave is fantastic with his camera and snaps stuff I barely notice. In many cases, he photographs a bird and then we look at the picture to "see what we saw".

One part of the country we'd never explored together was the Northwest, so....it was time! We tried to schedule the trip so we'd hit some of the popular spots after Labor Day and perhaps miss some of the crowds. The trip encompassed August 25-Sept 12.

Yes, radio went along and parks were activated. We didn't try duplicating this summer's Canada trip (100 activations of 88 parks). For one thing, I didn't want to unduly irritate my passengers. There is only so much tolerance of sitting in parks that can be expected of non-park-runners, especially when temperatures are in the 80s and 90s. We did manage to find places where most of the crowd could enjoy an air-conditioned visitor center or some scenery while I attempted to get my 10+ contacts.

I tried to map a lot of possibilities ahead of time, and we did manage to hit quite a few of them. NU7J joined us for a couple of days in Idaho and Montana. Trip stats:
